DISTRIBUTION OF INSTITUTE FUNDS TO LAKE COUNTY DISTRICTS

2012-2013 SCHOOL YEAR

PURPOSE: To encourage the continual professional development of Lake County educators, the

Lake County Regional Office of Education will assist by helping to defray the cost of the

comprehensive membership in the Lake County Educational Services Division. The Lake

County Regional Office of Education shall reimburse the school districts with a stipend that is

based on the size of enrollment in the district. The stipends are as follows:

•\$ 750.00 for districts with less than 1,000 students

•\$1,000.00 for districts with 1,000 to 1,500 students

•\$1,500.00 for districts with over 1,500 students

CRITERIA FOR FUNDING: Funds are to be used for the comprehensive membership with the

Lake County Educational Services Division. The district will pay the membership fee and

request reimbursement from the Lake County Regional Office of Education with appropriate

documentation. All requests for funding must be received by no later than November 30,

2012.
