COVID 19 Update

The district is now under new orders from the Governor for the closure of schools and social distancing though May 31, 2020, which means there will be no instruction in the school for the rest of the year.

Remote Learning

As a result of COVID-19 the district is in the remote learning phase which is going very well. Teachers are connecting with students in new ways with very few guidelines and the teachers have done a great job.

Superintendent Goals

Carissa Casbon LaTourette announced the board has suspended the goals previously set for the 2019-2020 school year and are adopting new expectations in their place. The board was presented with the new expectations in a document constructed by Ms. Casbon LaTourette with feedback from Dr. Lind and Denise Ide. The new expectations are geared specifically toward COVID-19.

SUPERINTENDENT REPORT

Dr. Lind is working on what returning to school in the fall looks like, which is undecided at this point. The district will plan around both options: remote learning and in person instruction. Millburn will be ready with a more defined remote learning plan that sets expectations regarding the reopening of school next year.

In order to return student belongings, teachers are starting to collect them and put them into bags for delivery next week. Teachers are coming in and cleaning out their classrooms also.

On May 8, 2020, there will be a parade at Gurnee Mills. The third grade team organized the parade where all the teachers and staff will be stationery and the parents and students will drive through. This will be a fun and exciting event.

BUSINESS OFFICE REPORT

Dr. Johns briefly highlighted the business office report first citing a need to amend the 2020 budget. The process will begin with a draft budget to be reviewed at the May Committee of the Whole Meeting and put on public display at the May 18, 2020, Regular Board of Education Meeting, for approval at the June Regular Board of Education Meeting.

The Property Tax Levy has been finalized at about \$5,500.00 more than originally estimated.

The snow plow truck in in limbo because Ford shut down their plants madding getting documentation and ordering impossible. Some summer projects have begun. There is a very good chance parking lot work will start in May as opposed to July. The district is working to get as many summer projects done early since students are not returning.

Sean Coleman thanked everyone who is putting in the effort to keep school going. He thanked the staff and administration on doing a good job.
