Audit Report 2019

Kathy Naughton worked with the business office, for the second year, in conducting the audit which went very well. All recommendations from last year were made and executed. Millburn did not receive a management letter this year and that is an accomplishment. While a new fiscal 2020 change Student activity account needs to be reported in district funds instead of separately, there were no formal issues found during the audit as it was a good process this year.

Fees - Registration, Activities, Clubs, Facilities Use

Dr. Lind recommends no change in registration and club fees. On a straw poll the board agrees.

Fund Balance Policy (Board Policy 4:20)

With regard to the balance of district funds, having some reserves the district is in a stable position having over 1 million dollars on an accrual basis, which includes working cash and the cushion that is in each of the funds or fund balance on an accrual basis. This is 10 percent of Millburn's current budget, a stronger position for the district to be in would be the 15 percent range.

Summer Projects 2020

Advertisement for bids and bid documents went out last week. Parking lot work bids are due by Jan 31. Dr, Johns will then work with the architect for district recommendations.

Renewal of Red Apple Academy License Agreement 2020-2021

It is recommended that the Red Apple Academy License be renewed as long as space is available. Red Apple pays Millburn 20 percent of its proceeds or they may elect to pay a flat fee. In the past, the program has had enough enrollment that they pay by percentage. The relationship between Red Apple and Millburn is good everyone is easy to work with.

House Lease Contract Renewal

Dr. Lind recommends renewing the house lease contract which is in its second year with the current tenant.
