# Summer School Updates

Dr. Lind announced summer school session 1 is half way completed and is going very well.

## District Goals 2020-2021

After sending the Board Notes on Friday, Dr. Lind asked the board for any comments regarding the goals, which were displayed. The goals include subject matter priorities directly related to social emotional health of students and staff, Student learning, curriculum, safety of students, and finances. The goals were linked to the google document with links for the board members to review.

# Kindergarten Reconstruction

The kindergarten team has proposed some restructuring regarding positions that kindergarten paraprofessionals hold. The proposal includes having one paraprofessional who will support all kindergarten teachers, along with adding one teacher to the kindergarten team, instead of hiring more paraprofessionals. The proposal came about after having worked this past school year in this same fashion. Adding a kindergarten teacher will help keep the kindergarten classes smaller, twenty students in each class being the goal.

# Increase of .1 FTE Adaptive PE

The Adaptive Physical Education teacher services students in grades pre-kindergarten through eight. The district is looking to increase the adaptive physical education teacher by half of a day to help lengthen the time in order to service all of the students on her caseload. Over the years, the number of students services has increased from approximately twelve students to approximately twenty students.

# Increase of 1 FTE Nurse

This year the district had an additional nurse who was assigned to an early childhood student who is medically fragile. That student will not return in the fall. The nurse also worked to support the nurse at MES when she was not with the student, who was in the building for 3 hours. When school begins in the fall, there is little to no information regarding what measures will be in place due to COVID. In anticipation of the hectic year, the recommendation is for Millburn to hire her full time to continue to support the anticipated needs. The recommendation is to hire her for 1 school year, at this time.

### Increase in Media Clerk .5

With the need for additional tech support, the district is recommending an increase in the Media Clerk position. With the need for additional teach support, the recommendation is to make the Media Clerk a full-time position.
