Financial Profile Score Presentation

Dr. Lind presented a printed document to Board of the Financial Profile Score from last year as this year's is not yet available, however in one month this year's could be updated. Dr Lind explained how the Financial Profile Score is built and calculated. The maximum score is a 4.0, Millburn had a 3.0.

Strategic Planning Presentation

Dr. Lind gave a brief overview explaining why the district is doing strategic planning before the planning process starts. The document presented began with analysis and assessment segment, which the district is entering into already. The process includes considering values, beliefs and goal setting. First goals are set, finances are considered, the process also considers who will be impacted by the decisions, and staffing levels, including abilities and funds are considered. In the end the final authority to decide what the plan will look like rests with the school board.

State Testing Results Summary

Dr. Lind presented a brief synopsis of the state test scores from last spring. Math scores were excellent. In ELA the district is headed in the right direction given the help of the current writing program also the new reading program will provide additional help where needed.

Corrected EIS Administrator and Teacher Salary and Benefits Report 2018-2019.

Dr. Johns presented the Corrected EIS Administrator and Teacher Salary and Benefits Report 2018-2019 as the last one that was presented was from 2017. The correct report is posted on the website under Business Office. Dr. Johns sent all board members a link to easily access the report.

Discussion of Board Goals

Since the district works to create goals, Ms. Casbon LaTourette and Ms. Ide introduced the idea for the board to create board governance goals to support the culture of learning. Ms. Casbon LaTourette received feedback from the board members regarding their thoughts on creating the goals. Being a collective effort, the goals will be created by collaborating with all school board members.

At the next meeting there will be a request for purchases over \$10,000.00 for Maxum Healthcare Services for the Registered Nurse for Special Education purposes. In November, Dr. Johns will have a long-range financial projection ready for the board. Also, within the next two to three weeks the audit should be completed. The levy process will be reviewed at the next meeting the actual levy presentation will be done, then the actual adoption will take place. This will happen over the next few board meetings. Lastly, Dr. Johns reported the property tax abatement decision will need to be made by February or March 2020.
