

**RESOLUTION AUTHORIZING AND DIRECTING  
THE TRANSFER OF INTEREST**

WHEREAS, the Board of Education (the “Board”) of Millburn Community Consolidated School District No. 24, Lake County, Illinois (the “District”) has created and maintained an Illinois Municipal Retirement fund in and for the District pursuant to the *Illinois School Code* (the “Code”) and its applicable regulations; and

WHEREAS, Section 10-22.44 of the Code authorizes the Board to transfer the interest earned from any monies of the District to the respective fund of the District that is most in need of such interest income as determined by the Board, provided such interest income has not been earmarked or restricted by the Board for a designated purpose, and is not interest earned on any funds for purposes of Illinois Municipal Retirement, Tort Immunity, Fire Prevention, Safety, Energy Conservation and School Security purposes, or Capital Improvements (the “exempted funds”); and

WHEREAS, there is currently in excess of \$3.300 in earned interest from investments in the District’s Debt Service and Transportation Fund to the credit of those funds. None of that earned and accumulated interest has been earmarked or restricted by the Board for any designated purposes and none of that earned and accumulated interest is from the exempted funds.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education, Millburn School District No. 24, Lake County, Illinois, as follows:

SECTION 1: The recitals contained in the preambles to this Resolution are full, true, and correct and the Board incorporates them into this Resolution by this reference.

SECTION 2: This Board of Education hereby authorizes and directs the transfer of interest from the District’s Debt Service and Transportation Fund to the District’s Operations and Maintenance fund, which is the fund determined by the Board to be most in need of such interest income.

SECTION 3: The School Treasurer is hereby authorized and directed to make any and all necessary entries on the District's books and records to evidence the transfer of said interest income.

SECTION 4: All resolutions or part thereof in conflict with this Resolution are repealed, and this Resolution shall be in full force and effect immediately upon its adoption.

**RESOLUTION OF THE BOARD OF EDUCATION DIRECTING THE SCHOOL  
TREASURER TO TRANSFER FUNDS FROM THE TRANSPORTATION FUND TO THE  
EDUCATION FUND AND THE OPERATIONS AND MAINTENANCE FUND**

WHEREAS, the Board of Education of Millburn Community Consolidated School District No. 24, Lake County, Illinois desires to remain in compliance with generally accepted accounting principles and those requirements set forth in the Illinois Administrative Code; and

WHEREAS, the Board of Education has determined that it is in the best interest of the School District to direct the School Treasurer to transfer certain funds from the Transportation Fund to the Education Fund and the Operations and Maintenance Fund to provide funds with which to meet those expenses properly made from the Education Fund and the Operations and Maintenance Fund pursuant to the Illinois Administrative Code.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education, Millburn School District No. 24, Lake County, Illinois, as follows:

SECTION 1: The recitals contained in the preambles to this Resolution are full, true, and correct and the Board incorporates them into this Resolution by this reference.

SECTION 2: This Board of Education hereby authorizes and directs the transfer of \$250,000 from the District's Transportation Fund to the Education Fund and the transfer of \$500,000 from the Transportation Fund to the Operations and Maintenance Fund, such transfers to be made effective June 30, 2021.

SECTION 3: The School Treasurer is hereby authorized and directed to make any and all necessary entries on the District's books and records to evidence the transfer of funds.

SECTION 4: All resolutions or part thereof in conflict with this Resolution are repealed, and this Resolution shall be in full force and effect immediately upon its adoption.

WHEREAS, amendments to the Illinois Administrative Code required changes in how Illinois school districts document the funding of, accounting for, and expenditures from the Capital Projects Fund; and

WHEREAS, the Board of Education of Millburn Community Consolidated School District No. 24, Lake County, Illinois desires to remain in compliance with generally accepted accounting principles and those requirements set forth in the Illinois Administrative Code; and

WHEREAS, the Board of Education has determined that it is in the best interest of the School District to direct the School Treasurer to transfer certain funds from the Operations and Maintenance Fund to the Capital Projects Fund to provide funds with which to meet those expenses properly made from the Capital Projects Fund pursuant to the Illinois Administrative Code.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education, Millburn School District No. 24, Lake County, Illinois, as follows:

SECTION 1: The recitals contained in the preambles to this Resolution are full, true, and correct and the Board incorporates them into this Resolution by this reference.
