#### **EXECUTIVE SESSION**

She said the Millburn Board is divided and the district is in a serious financial condition because of past bad decisions. She asked why questions can not be answered regarding the resignation of Superintendent Dr. Ellen Mauer. She said the tension caused by recent decisions is not in the best interest of the children.

NEW SUPERINTENDENT EMPLOYMENT CONTRACT – A motion was made by Lisa Scanio and seconded by Chris Stream to hire Jason Lind as superintendent with a three-year contract, at a salary of \$125,000 for the first year, effective July 1, 2011. On a roll call vote, the following Board Members voted Aye: Kenneth Dewitt, Diane Campbell, Robert Buehler, Chris Stream, Lisa Scanio and Robert Reding. Nays: Shawn Lahr. Absent: none. The motion passed.
