A Special Meeting of the Board of Education of Millburn School District 24, Lake County, Illinois, held at Millburn West School, was called to order at 7 p.m. by President Robert Buehler. <u>PUBLIC COMMENTS</u> – Scott Miller asked when the district will be able to bring back educators, and when class sizes will be able to start decreasing. He also asked how long increased class sizes are sustainable before there is a decrease in the quality of education.

#### INFORMATION/DISCUSSION ITEMS

PRESENTATION ON TRIMESTERS – Teachers Nancy Reding and Meghan Konicki gave a presentation on switching to a school year based on trimesters, instead of the current quarterly system. The presentation included information regarding which Lake County schools use trimesters, the results of a Millburn staff survey, and the benefits of making a change. Dr. Ellen Mauer said the change to trimesters will be in place for Kindergarten through Grade 5 next year. Grades 6-8 will continue on quarters.

<u>FINANCIAL UPDATE</u> — Howard Crouse of PMA presented the latest financial projections for the district. They included updated figures on the district's Equalized Assessed Valuation and the Consumer Price Index, and also took into consideration the staff cuts and increased fees for next year. Mr. Crouse said these actions have had a positive financial impact on the district.

ENERGY AUDIT - Shawn Lahr presented information he obtained from the Illinois Smart Energy Design Assistance Center. Board Members will review this information, in addition to information presented previously by Fanning Howey. It will be discussed at a future Board Meeting.

PRINCIPAL SEARCH – Jason Lind said the job opening for principal of Millburn Central School has been posted, and more than 30 applications have been received to date. Parents and staff were invited to complete an online survey. Results from the survey were used to create the candidate profile. The goal is to have a final candidate to present to the Board for approval at the May 16 meeting.

MINUTES OF SPECIAL MEETING OF FEB. 7, 2011 - The Board discussed the Minutes of the Special Meeting of Feb. 7, 2011, which included verbatim comments made during a roll call vote. Issues discussed included: whether comments should be made once the discussion has ended: if there is a precedent for including in the Minutes comments made during a roll call vote; whether the attorney had reviewed the comments; whether comments should be added for personal reasons; and the official purpose of the Minutes. The Board Clerk was asked to resubmit the Minutes as originally written. Approval of the Minutes will be included on the next Regular Meeting agenda.

PUBLIC COMMENT - Laura Brown reminded those present that the PTOs of both schools were sponsoring a Meet the Candidates forum on March 10. All candidates on the ballot in the upcoming School Board election have been invited. She asked if a phone call could be made to all parents to remind them to vote in the election. She also requested video streaming of Board meetings.

<u>STRATEGIC PLAN</u> – Lisa Scanio reported that the Strategic Plan survey has been distributed via email, and is also available on the district website. She encouraged everyone to complete the survey. The results will be used to determine areas of importance to the community as the Strategic Plan moves forward.

There being no further business, the Special Meeting adjourned at 8:41 p.m.
