These figures were compared to the actual figures from Fiscal Year 2011. Discussion topics also included loss of state aid and the amount of savings realized from last year's staff cuts. Supt. Lind reported that the State Bank of the Lakes is willing to issue Tax Anticipation Warrants at a 3.25 percent interest rate. This compares to last year's TAW interest rate of 4 percent. A motion was made by Lisa Scanio and seconded by Joseph Pineau to approve Tax Anticipation Warrants not to exceed \$3 million.
