AMENDED FY16 BUDGET – Dr. Stephen Johns said that the only change between the adopted FY16 Budget and the proposed amended budget is an increase of \$200,000 in the amount being transferred to the Capital Project Fund. The transfer is \$650,000 instead of \$450,000 that was in the original budget. The Proposed Amended Budget will be placed on public display for at least 30 days prior to adoption by the Board.
